#### Superintendent's Report

Dr. Hoffman shared that he and Dr. Reitz and Mr. Laudadio presented at the Raising Student Achievement Conference in St. Charles, the BPAC Christmas Party was held at Riverwood on with over 300 people attending, winter recess is December 21-January 3; Landmark's December 21-January 10. Dr. Hoffman also stated that the District 3 on 3 Tournament and Foundation Chili Cook-Off will be held on January 21 at Parkland School and finally, our next Board of Education Meeting will be at the Central Office on January 10<sup>th</sup> and will be held at Valley View on January 24, 2017.

#### Committee Reports

#### Curriculum Committee

Mr. Santopadre reported that the committee reviewed staffing for the 2017/18 school year and are recommending the staffing requests be put on the Consent Agenda for the next meeting. He also shared that we are have a Reduction in Force (RIF) for the Speech Language Pathologist Coordinator position. The committee had the first reading of revised policies 4:55, 4:55 Exhibit, 5:60, 2:125, 2:125 Exhibit, 7:270, 7:270 AP 1 & 2. At this time Mr. Sivertsen questioned a footnote regarding dispensing medication and opioids. Dr. Reitz will revisit with our Director of Health Services and district attorney.

#### **Building/Transporation Committee**

Mr. Hettermann, stated that committee reviewed Summer Projects which will range from \$3.5 million to \$4 million which is typical. Additionally, he stated that there will be a pre bid meeting on January 3, 2017, opening of bids, January 11, 2017 and the bids will be brought to the board for approval at the January 24, 2017 board meeting. He also stated that we will be going out for bus bids with District 156 in January.

### Finance Committee

Mr. Miller reported that the committee reviewed the levy, that State of Illinois is \$6 billion dollars behind in categorical payments to school districts. District 15 has not received a categorical payment since April 2016. The district has the appraisal for the land at Ringwood Road and Route 120 and will be meeting with the City of McHenry regarding the sale of the

land. Finally, Mr. Miller stated that the committee is also recommending the staffing requests be placed on the January 10, 2017 consent agenda for approval.
