Guiding Principles:

1. Follow the regulations and spirit of guidance from ISBE and IDPH
2. Prioritize the health and safety of all students and staff
3. Maintain an emphasis on prioritizing in-person learning for all students
4. Develop return to learn plans that recognize the impact COVID-19 has had on staff, students, and families
5. Focus on social-emotional and mental health supports that will support a successful transition back to in-person learning
6. Focus on academic supports that mitigate the impact COVID-19 has had on students
7. Be able to develop contingency plans that allow for last-minute changes from ISBE, the State, IDPH

Recent Guidance from ISBE

On May 19, 2021, the Illinois State Board of Education unanimously adopted a Resolution Supporting In-Person Learning that supports the Illinois State Superintendent of Education Dr. Carmen I. Ayala in making the following declaration after the conclusion of the current academic school year, subject to favorable public health conditions at that time:

Beginning with the 2021-22 school year, all schools **must** resume fully in-person learning for all student attendance days, provided that, pursuant to 105 ILCS 5/10-30 and 105 ILCS 5/34-18.66, remote instruction be made available for students who are not eligible for a COVID-19 vaccine **and** are under a quarantine order by a local public health department or the Illinois Department of Public Health.

Planning for the 2021-2022 School Year

- At this time, data and guidance supports that District 15 return to a full, five days a week, in-person learning model for all students.
- District 15 will provide remote learning in limited circumstances for students who meet both criteria outlined in the resolution (i.e. not eligible for a vaccination AND is in quarantine) but the expectation is to not provide optional remote learning outside of those scenarios.
- ISBE is predicting the CDC / IDPH will release its updated guidance for schools in the next couple of weeks. They are recommending that schools plan for both looser CDC guidance and the potential that current mitigations will remain in place.



Rationale for Full In-Person Return


- Meets the regulations and spirit of most recent guidance from ISBE
- Illinois is now in Phase 5 which recommends the implementation of full, in-person learning for all students
- Health conditions continue to improve in Illinois and McHenry County (we meet all four metrics that we have monitored since last year)
- COVID testing options are more readily available
- Vaccine availability exists for all staff and students ages 12 and above
- Community preference

Current Guidance/Rules from ISBE

- Universal mask wearing by vaccinated and unvaccinated individuals in schools.
 - Masks are not required outside.
- Social distancing of 3 - 6 feet must be observed to the extent possible
- Contact tracing, periods of isolation, and quarantine must be performed in collaboration with the local health department for unvaccinated individuals
- Symptom self-certification is required of students, staff, and visitors
- Continued schoolwide cleaning and disinfection
- Frequent and proper hand hygiene

Social-Emotional Supports Upon Return

 - Self Management
 - Social Awareness

 - Responsible Decision Making
 - Trauma informed practices for students and families
 - Challenges faced given the pandemic
 - Difficult experiences
 - Climate and Culture of School Communities
 - Educational impact
 - Opportunities to celebrate
