Dr. Reitz stated that there is a vacancy on the Board as Mrs. Riemann has resigned. The community has until July 9, 2021 to submit a letter of interest. Interested candidates will be interviewed in Closed Session on July 14, 2021 Dr. Reitz also shared that to date we have approximately 2,500 student registered, approximately 950 still to register, and over 330 new students have registered. Landmark students will return to in-person learning on July 21st.

Dr. Reitz and Dr. Laudadio shared a PowerPoint with the Board on the district's plan to return to in person learning for the 2021-2022 school year. They shared health metrics, updated IDPH and CDC guidance.
